THE LAST TIME WE AIRED THE PROGRAM, SUNDAY, FEBRUARY 8 AT 8 AM WITH THE EMERGENCY CHANGE ANNOUNCING THE NEW DATE MOVED TO JUNE. WE DID NOT RE-AIR THE PROGRAM AFTER THAT DATE BUT DID COVER THE TOPIC ON-AIR WITH OUR SPOTS AND WITH NEWS REPORTS ON NJN NEWS. THE OMISSION TO AIR ONE ADDITIONAL PROGRAM AFTER APRIL 1ST WAS AN OVERSIGHT. WE NOTE THAT NJN OTHERWISE PROVIDED EXTENSIVE COVERAGE OF THE APPROACHING JUNE 12 DEADLINE AND RECEIVED BUT 12 CALLS IMMEDIATELY AFTER TERMINATING ANALOG OPERATIONS THAT DAY. TO DATE, NJN HAS RECEIVED A TOTAL OF ONLY 238 CALLS REGARDING THE SWITCHOVER TO ALL-DIGITAL OPERATIONS.
